1. Introduction

By law a vehicle's tachograph must be downloaded every 90 days and driver cards every 28 days in order to comply with EU Regulation 561/2006.

This report has been compiled by us to save you time gathering details of pricing and feature information from the tachograph analysis software suppliers.

The list is not exhaustive but represents the main players. We try to keep the list as up to date as possible but as with all products, prices and features can change over time.

The report is split into two categories:

- software installed on your own computer where you retain and analyse your data
- online subscription services where you transmit your data over the internet for third party processing

The following describes some of the column headings:

INFR RPTs (EU Driver Hour Infringement Reporting)

Indicates whether the software analyses and reports upon EU Driver Hour infringements such as driving in excess of 4½ hours in a session, exceeding 10 hours driving in one day or 6 days driving within the last 7 days, etc.

To be candid, if you purchase activity (driving, work, break, POA) reporting software then a product that brings to your attention driver infringements is a wise investment. Let your computer take the strain as manual calculation of infringements is a tedious, error prone and time consuming task.

Unintentional mis-use of company and driver cards is quite common and this is another aspect that infringement reporting detects.

Our product, Pitstop Flag has full infringement reporting essential to maintaining a legally run fleet of vehicles and can save you £100's over comparable products.

Look for a "Yes" in the INFR RPTs column.

WTD RPTs (Working Time Directive Reporting for Mobile Workers)

You must also consider the EU Working Time Directive for mobile workers. It relates to rest and working period regulations designed to protect both drivers' and third parties' health and safety.

Software applications including this functionality are marked "Yes" in WTD RPTs column.

This box indicates the annual licence fee required to activate your product for another year.
